

Identity Verification

Admin can view reports per county, drill-down reports and reports of bounced contacts.

Reports per county indicate the count of text / emails sent and/or failed, while drill-down reports indicate the count of texts/emails sent.

Reports can also be seen on the number of individuals who opt out of receiving notifications and other information.
